## JESSE SMITH - TO REQUEST SITE PLAN APPROVAL FOR SMITTY'S AUTOMOTIVE REPAIR AT 175 HAMMER BOULEVARD.

City Administrator Ron Salvesen said on August 10, 2017 the Hyrum City Planning Commission recommended site plan approval Smitty's Automotive Repair at 175 Hammer Boulevard with the following conditions: 1. Building and Fire Codes have to be met; 2. A fence must be installed if there is outside storage; and 3. Landscaped areas be cleaned up and maintained.

Jesse Smith said he has worked at several different car repair shops in the Valley and ten years ago he went out on his own. business is large enough that he needs a larger shop where he can work on several vehicles. He will have a sign out front of the business with his business name on it.

ACTION

Councilmember Rasmussen made a motion to approve the site plan for Smitty's Automotive Repair at 175 Hammer Boulevard with the following conditions: 1. Building and Fire Codes have to be met; 2. A fence must be installed if there is outside storage; and 3. Landscaped areas be cleaned up and maintained. Councilmember Clawson seconded the motion and Councilmembers Adams, Bingham, Clawson, James, and Rasmussen voted aye. The motion passed.

# SUZANNE STOUT, NEIGHBORHOOD SOLUTIONS - TO DISCUSS A PROGRAM THAT PROVIDES LOW INTEREST LOANS FOR REPAIRS AND UPDATES.

Suzanne Stout with Neighborhood Solutions explained Neighborhood Housing Solutions Program. It is in partnership with State of

Utah and offers a home repair program to qualified households to assist homeowners in financing home repairs at an affordable interest rate of one to three percent. Payments are based on household income and repayment ability. Eligible repairs include roof replacement, update plumbing, heating, cooling and electrical systems, replace siding, replace windows, eliminate health or safety hazards, and add accessibility features. Mobile or manufactured homes built before 1976 are not eligible. Works has to be completed by licensed contractor.

The City Council suggested Suzanne submit an article with the information she has provided to the City Office and it could be included in the City's newsletter.

# ROSS STENQUIST, LITTLE BEAR CREEK - TO REQUEST APPROVAL OF AN AMENDMENT TO THE FINAL PLAT OF LITTLE BEAR CREEK

Ross Stenquist said the Final Plat for Little Bear Creek needs to be amended to change the way the detention pond is maintained. He would landscape and install a sprinkler system in the detention pond but rather than setting up a Home Owner's Association to maintain the pond he wants to include it in with the building lot to the east. It would be sold with the restriction that the property owner had to maintain the landscaping and could not fill it in or put any structure on the detention pond.

Councilmember James said he thinks it would be a great idea but is concerned about what will happen if the owner doesn't maintain the area.

Councilmember Rasmussen said there needs to be strict requirements included on the plat on what is expected of the detention pond lot owner.

## ACTION

Councilmember Rasmussen made a motion to approve the amended Final Plat for Little Bear Creek at 275 North 575 West with the following condition: 1. On the Final Plat Notes #5 be amended to read as follows "5. Notice to purchase of Lot 202, Detention Basin and Storm Drain Easement is located within Lot 202 and will be maintained by the owner of Lot 202 as a detention basin. detention basin will not be filled in, regraded, built upon, or otherwise altered from its intended purpose." Councilmember James seconded the motion and Councilmembers Adams, Bingham, Clawson, James, and Rasmussen voted aye. The motion passed

## OTHER BUSINESS:

## CONSIDERATION AND AWARD OF BID FOR THE EAST HYRUM SUBSTATION ELECTRICAL DISTRIBUTION LINE UPDATES.

City Power Superintendent Matt Draper said due to the size and unknowns of this project it has been difficult to get actual bids on this project. He requested an outline of construction costs from three electrical companies and only Hunt Electric, and Cache Valley Electric submitted an outline. He recommended going with Hunt Electric because Hunt will allow the City Lineman to help with the work. Cache Valley Electric is union and will not allow the City Lineman to help with the project. The more money that can be saved in labor costs will help the City plus give the City Lineman more experience.

ACTION

Councilmember Rasmussen made a motion to award the bid for the East Hyrum Substation Electrical Distribution Line Updates to Hunt Electric and for labor and materials to not exceed \$500,000. Councilmember Bingham seconded the motion and Councilmembers Adams, Bingham, Clawson, James, and Rasmussen voted aye. The motion passed.

## CONSIDERATION AND AWARD OF BID FOR THE BLACKSMITH FORK TRAIL DESIGN.

City Administrator Ron Salvesen said the City received three bids from BioWest, Cache Landmark, and JUB. The Committee met and reviewed all proposals before opening the bid tabulations.

Councilmember Rasmussen said he needed to declare a conflict of interest because the company he works for would be a subcontractor for BioWest. He will abstain from the discussion and voting.

Councilmember James made a motion to award the bid for Blacksmith Fork Trail Design for \$37,755.00. Councilmember Bingham seconded the motion Councilmembers Adams, Bingham, Clawson, James, Rasmussen voted aye. The motion passed.

CONSIDERATION AND AWARD OF BID FOR CULINARY WATER PIPELINE

## REPLACEMENT AND STORM WATER DRAINAGE PROJECTS.

City Administrator Ron Salvesen said after going through the bid process for this project the City didn't receive any bids. However, Aqua Engineering then went and approached several who had expressed an interest in bidding the projects. Aqua was told by several companies that they didn't have time to do the project this year but was able to get two quotes from construction companies.

Aqua Engineering has reviewed the bids and is recommending the City award the bid for the 2017 Culinary Water Pipeline Replacement and Storm Water Drainage Projects to Allied Construction.

Councilmember James made a motion to award the bid for the 2017 Culinary Water Pipeline Replacement and Storm Water Drainage Projects to Allied Construction for \$469,308.27. Councilmember Clawson seconded the motion and Councilmembers Adams, Bingham, Clawson, James, and Rasmussen voted aye. The motion passed.

## CONSIDERATION AND ACCEPTANCE OF IMPROVEMENTS IN ROLLING HILLS SUBDIVISION PHASE 3.

City Administrator Ron Salvesen said Rolling Hills Phase 3 is completed and the City Engineer and staff is recommending the City Council accept Phase 3 of Rolling Hills Subdivision.

#### ACTION

Councilmember Rasmussen motion to accept the improvements Rolling Hills Phase in 3 upon recommendation by the City Engineer and City Staff. Councilmember Clawson seconded the motion and Councilmembers Adams, Bingham, Clawson, James, and Rasmussen voted aye. The motion passed.

## CONSIDERATION AND APPROVAL OF AN OFFER TO PURCHASE HYRUM CITY'S PARCEL 01-042-0031.

City Administrator Ron Salvesen said the City has received an offer on the last lost on Main Street near 100 East. The offer is for \$58,000 for parcel #01-042-0031.

#### ACTION

Councilmember James made a motion to accept the offer of \$58,000 for the City's Parcel #01-042-0031 located at approximately 83 East Main. Councilmember seconded the motion and Councilmembers Adams, Bingham, Clawson, James, and Rasmussen voted aye. The motion passed.

## APPOINTMENT OF YOUTH COUNCIL ADVISOR.

Councilmember Bingham recommended appointing Kathryn Fielding as a Youth Council Advisor.

Councilmember Clawson made a motion to appoint Kathrin Fielding as a Youth Council Advisor. Councilmember Bingham seconded the motion and Councilmembers Adams, Bingham, Clawson, James, and Rasmussen voted aye. The motion passed.

## MAYOR AND CITY COUNCIL REPORTS.

Councilmember Adams said National Night Out Against Crime was a There were over 700 hamburgers served to an great success. estimated 550 people. The Cache County Sheriff's Office did a great job and people enjoyed having the bomb squad there. People enjoyed watching the Armor Combat League. He thanked the City Council for its help.

Councilmember Rasmussen said Museum Director Jami VanHuss will be at the next City Council Meeting to report on the Museum. Jami is hosting an Historic Home Tour on September 9 from 10:00 a.m. to 4:00 p.m. and the Candy Cabin will be open during that time.

Councilmember Clawson said the end of the Summer Reading Program Party was held at the Logan Aquatic Center and it was well attended as usual.
