

RESOLUTION 20-06

A RESOLUTION SETTING PRESSURIZED IRRIGATION WATER RATES AND DISCONNECT/RECONNECT FEES.

WHEREAS, on January 6, 1994, the Hyrum City Council passed and posted an ordinance adopting the "Hyrum City Municipal Code", a recodification of municipal ordinances encompassing the "Revised Ordinances of Hyrum City" and ordinances adopted through July 15, 1993; and

WHEREAS, Title 13 of the Hyrum City Municipal Code sets forth regulations governing municipal utility services; and

WHEREAS, Chapter 13.20, Section 13.20.190, of the Hyrum City Municipal Code, authorizes periodic adjustments to municipal irrigation water rates by resolution of the governing body; and

WHEREAS, Hyrum City is not proposing an irrigation water rate increase and has not increased rates since March 19, 2015;

WHEREAS, there have been incidents where Hyrum irrigation customers choose to disconnect from the irrigation system and then at a later date decide to reconnect to the irrigation system;

WHEREAS, City Staff is recommending imposing a reconnect and/or disconnect fee for residents who choose to reconnect or disconnect service from the irrigation system;

WHEREAS, after careful consideration and review of the financial requirements of the irrigation water system, the governing body has determined it is both necessary and proper to charge a disconnect and reconnect fee for irrigation water service;

NOW, THEREFORE, BE IT RESOLVED by the City Council of Hyrum City, Cache County, State of Utah, that the user rates for irrigation water service from the municipal piped irrigation water system shall be as follows:

MONTHLY RATES:

.00 to	0.50 acres	11.10
.51 to	1.00 acres	13.58
1.01 to	1.25 acres	14.83
1.26 to	2.49 acres	18.06
2.50 to	3.74 acres	24.04
3.75 to	4.99 acres	30.60

5.00 to 9.99 acres	38.66
10.00 to 14.99 acres	56.25
15.00 to 19.99 acres	79.94
20.00 acres and above	107.96
Mountain Crest High	540.00

All billings for irrigation service furnished to customers of Hyrum City municipal irrigation system be increased by twenty percent (20%) during each of those months in which the city supplements surface water stream flow with water pumped from a municipal well.

CONNECTION AND DISCONNECTION

Disconnect and/or Reconnect Fee \$200.00 each time

BE IT FURTHER RESOLVED, that this resolution shall become effective on June 4, 2020.
