A RESOLUTION AMENDING THE HYRUM CITY CANYON LODGE RENTAL FEE AND DEPOSIT SCHEDULE, AND SETTING RENTAL TIMES.

WHEREAS, Hyrum City owns and operates a small lodge in adjacent to the Canyon Power Plant in Blacksmith Fork Canyon known as the Canyon Lodge; and

WHEREAS, Hyrum City allows the Canyon Lodge to be rented for a variety of public and private functions; and

WHEREAS, the Canyon Lodge is served by a septic tank the Canyon Lodge has a maximum capacity of 60 people; and

WHEREAS, the Canyon Lodge is a rental property and has been left unclean, had damage, or rental rules were not followed by those renting the building and the City has no repercussion since a deposit is not charged on the building; and

WHEREAS, the Canyon Lodge is used primarily from June through August it is important to rent the building efficiently to allow additional rentals; and

WHEREAS, the Hyrum City Office Staff is recommending the City Council set a fee and deposit schedule similar to the City's other buildings fee and deposit schedules along with splitting the rental from all day to two rental times per day 7:30 a.m. to 3:00 p.m. and 4:00 p.m. to 11:59 p.m.;

NOW, THEREFORE, be it resolved that the Hyrum City Council hereby approves and adopts the Hyrum City Canyon Lodge Rental Fees and Deposit Schedule attached hereto as Exhibit "A". These fees and deposits may be revised from time to time by resolution.

BE IT FURTHER RESOLVED, that this resolution shall become effective upon adoption.
