	or the yard and accessory buildings being a part of such residence. Home occupations shall not change the character of the residence or the residential neighborhood. A business license is required for some home occupations. They shall be issued for a one-year period and are renewable. The City Council may review a license in reaction to neighbor's complaints and may revoke it if evidence warrants this action.
Mr	B. Two levels of home occupations exist. Both are required to maintain all of the standards of a home occupation business license.

C.	Level offe applicants are in occupation caregories that the city coordinates
	determined have virtually no negative impact on residential neighborhoods.
	Level one applicants do not require a license. Occasional businesses operated
	by a minor are not required to obtain a business license.
